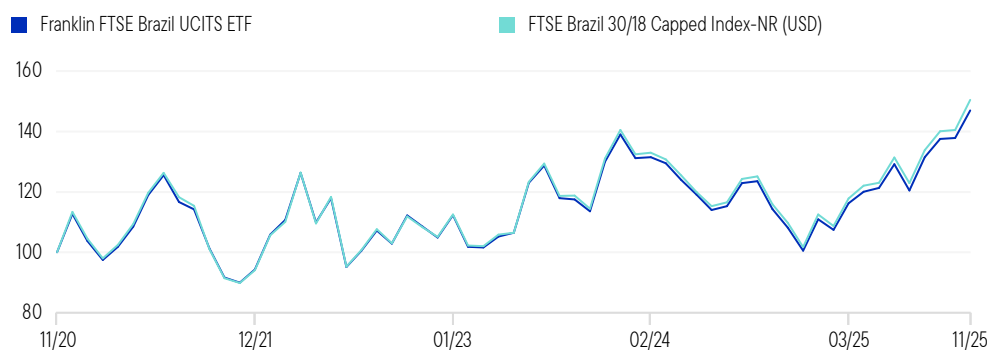

Glossary
